Update, Road #20, Sunny Slopes Road

Howard informed the board he has a meeting scheduled with Attorney Weeks to get the information for the coming hearing. The hearing is scheduled for May 25.

Finnebott, Bennion, and SunUp Intersections

JUB did core drilling and excavating this week to find the types of soil present. Howard said it was all clay soils. He stated the construction will have to take place during dry weather.

**District Security Systems** 

Howard contacted the company that currently monitors the district office fire system. They said at least two of the security systems would need to be replaced. He has not received the price for the materials to replace the systems. Mangan asked if this would include cameras. Howard replied he had not considered that. He said he is not pleased with the current company's lack of customer service. Mangan said it is good to have a system that has an alarm; however he would like to have cameras to identify any perpetrators. The cameras in the long run may pay for themselves. Johnson asked if this would be something the district would need to bid. Howard said he did not know at this point. Howard will continue to look into the replacement.

Paved roads were swept for the second and third times as needed depending upon the amount of sanding material that was remaining from winter.

The crew completed the moving of materials in the Johnson Pit in preparation of this year's crushing. A portion of the quarry was shot with explosives Monday of this week. The second portion to be shot is planned to be done on Friday of this week. This should conclude the blasting for the crushing.

Kelly, PJ, Spark, and Rick attended a T2 class on graveled roads.

A snowfall on the 10th caused for plowing and sanding in the Sun Up Bay area.

An emergency repair was made to a culvert on Cave Bay Road. A few other culverts were repaired or replaced.

Surplus equipment was prepared for auction.

The fuel island at Worley was inspected by the EPA. The site passed inspection.

The district assisted JUB in the digging of test holes for the Sun Up, Bennion, and Finnebott Intersection project and also on Burton Road for the Bozzard Creek Crossing.

Black Rock Slide Debris Billing

Howard asked the board if the district should bill Black Rock for the cleanup of the debris caused by a broken water line. Mangan felt the wet weather was a contributing factor in causing the broken line; therefore the district should not bill Black Rock. No action was taken to bill Black Rock.

First Meeting in November

The district originally scheduled its first meeting for November 4 assuming the convention would be the week of the November 7. Richel asked if the board wanted to change the meeting back to November 8 since there will not be a conflict with the convention.
