# On The Road

The crew plowed snow, sanded, and applied anti-ice to roadways as needed.

Many of the graveled roads were developing potholes this month, as is the norm for wet weather. Crews hauled light loads of gravel to fill the potholes. This work is temporary at best due to the water being held in the potholes, but it does give the traveling public a smoother ride for a while.

Roads were checked district wide for water runoff damage due to rain and melting snow. Water was channeled off and away from the road as needed.

Crew began sweeping the roads to remove winter sanding material.

Some crewmembers repaired signs. A list of signs needing repaired was created by survey of them the last couple of months.

Four crew members went to an aerial man-lift training course as East Side Highway District.

Woody debris was dumped in the middle of Setters Road west of Drechsel Road. The crew cleaned it up immediately after being notified of the problem.

Full grading began on the graveled roads west of Worley on the 18<sup>th</sup>. Three graders were working in conjunction with each other in this area.

Rose Creek Road had a full pad of gravel hauled on it as it has been several years since it was graveled last and needed it.

Four crewmembers attended the SEEP Certification class for continuing education.
