Work Progress Report

On The Road

All roads in the district were checked during and after a two-day rain event. Damage, with the exception of Bellgrove Road, was minimal.

A test pit was dug adjacent to Idaho Road for a culvert to be replaced under the Tribal Fisheries fish crossing grant.

Concrete was pumped under the K- rail barriers adjacent to Bellgrove Road to repair a cavity that was etched out during spring run-off. The drainage was lined with concrete as well to prevent further erosion.

The second application of HFE-150 was applied to Loffs Bay Road on the participation project portion of the road. Also, the first and second applications were applied to Bellgrove Road where the enhanced maintenance was performed.

A culvert was placed under Elder Road where flooding issues occur on a regular basis. This was included as part of the grant that CDA Tribal Fisheries obtained.

Hot-mix asphalt patching is underway. The crew is targeting areas to be sealed this year and next as well as those areas with notable deficiencies. A large portion of time was spent on Cave Bay Road.
