WHEREAS, Idaho Code 40-1309 gives the highway district the power to purchase personal property, and

WHEREAS, the board has found it can purchase a snow blower at a competitive price at auction, and

WHEREAS, Worley Highway District has \$25,000 for the purchase of a snow blower for the 2018-19 fiscal year.

NOW, THEREFORE, BE IT RESOLVED, that the district supervisor or his assignee is authorized to purchase a snow blower at auction that would fit the needs of the district not to exceed the budgeted amount for the 2018-19 fiscal year.

The crew filled potholes in graveled roads where the conditions were the worst. This is a temporary measure to soften the impact of the potholes until the roads firm up enough to begin grading.
