APPROVAL OF MINUTES

Life and Disability Insurance Renewal

Richel reported that Unum, the District's current insurance provider, is raising the rate for life and disability insurance by 36%. Principal Insurance has quoted 2 policies with comparable coverages, at a lower 28% increase.

Miller MOVED to use Principal Insurance, Option 2 for the renewal of the life and disability package. Johnson SECONDED. Mangan CONCURRED. The Motion PASSED UNANIMOUSLY.

There is a disconnect in the pavement of the Club's project and the district's asphalt on the east end of the project. The contractor will be correcting that later in the spring. No additional information this month.

3. Russu Addition, Minor Subdivision, Vogel Road:

Staff has not heard from Eli since he attended the district meeting on January 30, 2019. No additional information this month.

4. Ritz Ranch, Minor Subdivision, Loffs Bay Rd.:

I checked with Kootenai County as to the status of this subdivision and was told that it is "On Hold" in their office. No additional information this month.

5. Lake Vista Estates, Minor Subdivision, Bennion Rd.:

The board's site visit is pending the melting of the snow. No additional information this month.

6. The Club at Black Rock PUD Amendment:

The owners would like to offer the district Payment in Lieu of Construction for the 13 additional units created. This offer is made to reduce the expense of traffic studies and the time lost working toward quantifying the required road improvements. The owner(s) or their representative is here today to address the board.

Van Houten is requesting, on behalf of his client, that the Board waive any interest that would normally be applied to a payment plan on the PILC fees. Mangan asked that Van Houten and Howard work to create a draft Road Development Agreement (RDA), outlining any work to be done, timeframes for completion of the work, and a deadline for PILC fees to be paid by. He directed that a condition be included on the RDA, stating that if the PILC fees are not paid in full, by the deadline, the interest waiver will be null and void. The Board will look at the timelines and all other conditions when the draft is presented and make a decision at that time.
